From North and West

From I-90 EAST, follow signs for I-787 SOUTH (Exit 6-A, Albany/Rensselaer). Get off Exit 4-B (Clinton Avenue). Get into the LEFT hand lane and at the traffic light at the bottom of the exit ramp, take a LEFT onto Broadway.

At the fourth traffic light, take a RIGHT onto State Street. Take the first LEFT onto Green Street. There will be a small open parking lot in front of the parking garage with an attendant. Leave your keys with him and bring your parking ticket with you to the office to have it validated.

An Alternate Exit if Clinton Ave. is Closed

From I-90 EAST, follow signs for I-787 South (Exit 6-A, Albany/Rensselaer). Take Exit 4-A Colonie Street/Columbia Street. Go down approximately ½ mile- ¾ mile and take a RIGHT onto COLUMBIA STREET. Go to the traffic light and take a LEFT onto Broadway. At your second traffic light take a RIGHT onto State Street. Take your first LEFT onto Green Street. There will be a small open parking lot in front of the parking garage on the left with an attendant. Leave your keys with him and bring your parking ticket with you to the office to have it validated.

From the South

Take the NYS Thruway North to Exit 23.

After the toll booth, go straight and follow signs for I-787 NORTH.

Take Exit 4 (Broadway), staying to the left on the ramp. At the end of ramp, from the left hand lane, take a left at the light. Bear RIGHT at the next light onto Broadway. Go straight through the stop light at Hudson Street. Turn LEFT at the second traffic light onto State Street. Take your first LEFT onto Green Street. There will be a small open parking lot in front of the parking garage on your left with an attendant. Leave your keys with him and bring your parking ticket with you to the office to have it validated.

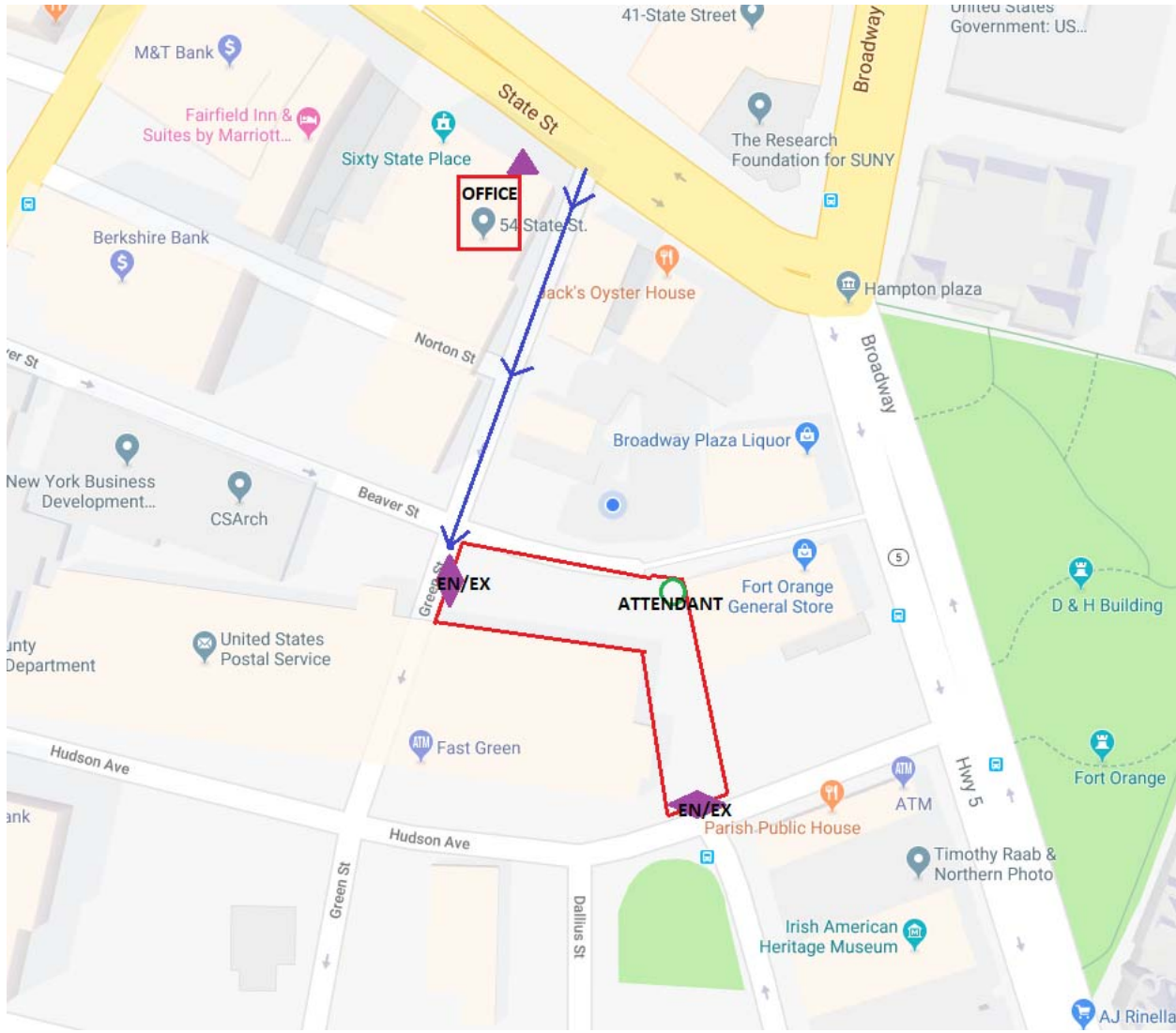
FROM THE PARKING LOT TO THE OFFICE

Once you leave the parking lot, walk down Green Street towards State Street. At the corner of Green and State Streets, take a LEFT. 54 State Street is on the corner of State & Green Streets. Walk into the building and take the elevator to the 10th floor. We are the first door off the elevator.
